654 cars displayed in 36th annual Seal Beach event

The 36th annual Seal Beach Car Show, held on April 27, surpassed all expectations, drawing its largest crowd and showcasing the most vehicles in its history. Enthusiasts from across the region displayed 654 classic cars and hot rods throughout Old Town, including Eisenhower Park, the pier, and Main Street.

Attendees were treated to a diverse array of vehicles, ranging from vintage hot rods to custom-built marvels, providing an unforgettable experience for all.

The day kicked off with a moving rendition of the National Anthem by Prestyn Smith, followed by a presentation of the colors by the Southeast County Young Marines, with Chamber President Juni Banico serving as Emcee.

Remington the sea lion is doing well at Pacific Marine Mammal Center

She came ashore in Seal Beach on April 8

A female sea lion came ashore in Seal Beach earlier this month. One of her human friends recently provided an update. She's doing well.

"In the early morning hours of April 8th, 2024, a fragile sea lion pup, whom we now call Remington ('Remi' for short), was found abandoned by its mother on a beach blanket under the Seal Beach pier," wrote Darin Denos in

an April 24 email to the Sun.

"When approached by an anonymous 'local' beach goer, lil' Remi burst out of the blanket as if to say 'hello'. The good Samaritan contacted Pacific Marine Mammal Center (PMMC) who immediately dispatched their team members, Christina Robinson & Shawn Abbey, to come to Remi's rescue," Denos wrote.

"Once approached by rescuers, despite her weakened condition, Remi climbed up onto the seawall and posed for a few heartwarming photos. But she clearly wasn't feeling well and laid back down

City Council District roundup

Inflation in Leisure World, shuttle service in Old Town, paving in College Park East

Inflation is bothering Leisure World residents. Shuttle service begins in Old Town. Paving begins in College Park East this week. Coffee with a Cop will come to District Two soon.

The Sun recently asked the five council members what was happening in their districts.

The answers below appear in the order received.

• District Five Councilman Nathan Steele

"The chief concern of many of my neighbors is the cost of living adjustments that have had a huge impact on people's sense of security. The GRF [Golden Rain Foundation] dues maxed out – limited by law to 20% increase a year. The Mutuals dues mostly maxed out 20%.

"Many of my neighbors live on fixed income social security and these increases have hit budgets very hard. This makes it hard for Water Wastewater rate hikes to 'pile on' top of those increases. But, we are dealing with the infrastructure of water and wastewater that are in need of upgrades, upgrades that will be much, much more expensive in 5 years. (It was explained by a municipal water expert at the recent OC Council of Governments annual meeting that cities get 'one bite at that apple once every 10 years.') Only one of my colleagues care about doing the right thing and investing now to avoid the inevitable difficulties in future years.

"So, both GRF and most of the Mutuals increased their dues by the state-limited maximum, and then the insurance bill came in \$2.5 million higher than expected. GRF board has elected to cover that increase from reserves this year, which means that next year's dues increases at GRF and





One of the longest consistently running events in Sunset Beach, the Las Damas annual Art Festival is scheduled for Mother's Day weekend, May 11-12.

For more than half a century, Las Damas has presented this traditional outdoor event in Sunset Beach to allow the community to enjoy some of the best arts and crafts in the region along with art created by some of the area's most talented artists.

Las Damas is a volunteer women's non-profit organization that promotes the arts, philanthropy, and education. Las Damas contributes 100% of the profits from the Sunset Beach Art Festival to local public schools, and local non-profit organizations, including continuing education grants for residents.

"This year, we have more than 125 artisan vendors featuring only hand-crafted items that will line the Green Belt from 7th Street to Broadway in Sunset Beach," said Las Damas spokesperson Natalie Vaughn.

In addition, she said, festivalgoers will be able to enjoy live music from popular local bands on both days of the festival, from 11 a.m. until the festival closes at 6 p.m. on Saturday and 5 p.m. on Sunday.

Two beer gardens, one featuring a local favorite Riip Beer Company, will be available, said Vaughn, accompanied by a variety of food trucks able to satiate the entire family.

These include local favorites Taco Surf and TK Burger to specialty trucks like Hulu Girls Shave Ice and 1 oz Coffee, she added.

There will be a special children's area to keep the little ones entertained along with an Art Gallery located in the Community Center for festival-goers to explore this year's art competitors and



City Council receives report of contracts approved by city manager, department heads

The council on April 22 unanimously received and filed City Manager Jill Ingram's quarterly report of contracts approved by Ingram or by Seal Beach department heads.

The report covered contracts approved between Jan. 1 and March 31, 2024.

This was a Consent Calendar item. Consent items are voted on collectively, without discussion, unless removed for separate consideration. Nothing was removed from this week's calendar.

"The City Manager has the authority to approve and execute contracts up to the amount of \$40,232," according to the staff report prepared by Deputy City Clerk Brandon DeCriscio.

"Seal Beach Municipal Code Section 3.20.005 authorizes the City Manager to delegate spending authority to Department Heads,' DeCriscio wrote.

"For departments other than the Director of Public Works and the Director of Finance/City Treasurer, this authority shall not exceed \$15,000 per purchase or contract," DeCriscio wrote.

"For the Director of Public Works, the limit is established per the City's Charter Section 1010," DeCriscio wrote.

The City Charter spells out the procedure for determining the Public Works director's limit.

"On June 1st of each year, the City Engineer shall compute the percentage difference between the current Engineering News Record Construction Cost Index – 20 City Average (ENR) and the ENR for the previous June 1st. The City Engineer shall adjust the bidding threshold amount by such percentage, rounding to the nearest dollar. The City Council shall review such adjustment at a public hearing and upon Council confirmation; the bidding threshold amount shall be the adjusted figure," according to Section 1010 of the Charter. (You can look up the Charter on the city government website.)

On July 24, 2023, the council approved the Public Works director's limit of \$40,232.

"For the Director of Finance/ City Treasurer, other than for Finance Department expenditures which are set at \$15,000, there is additional authority to authorize

Against gate system project

GRF unnecessary, unsafe, unapproved, and very expensive Project must be stopped.

In Sun Newspapers (April 18, 2024) I wrote that GRF management started unprepared without Engineering study and required approval by OCFA Project "RFID Gate Access system". Today I would like to present some specific details of how it works.

On one day as a lawful driver, I stay in line to enter LW at Main Gate. Three cars and the OCTA bus made an illegal right turn from the middle lane, two cars crossed both lanes from the West side of the Globe. The worst happened when a Firefighter emergency vehicle came. After few unsuccessful attempts to enter, they turned toward St. Andrews Dr. Entrance.

I talked with firefighters. They a very concerned about the situation. I was told that if they tried to use North Gate and St. Andrews Dr. entrances, which are not certified by OCFA, they do not have visitor parking and a place for a u-turn by unauthorized vehicles.

Firefighters even tried to enter the community through Exit from LW at Main Gate.

When the project was presented, nobody said that every vehicle entering gates must stop before the barrier. Before cars with Decals and guest Passes just slow down at the entry to help the Security officer to verify the Decal or Pass. Now were added millions of stops before the barriers. There is no Traffic Study done to verify will be Gates able to manage the existing traffic.

According to the rules (quote) "permanent guest will need to stop and show the gate guard their ID. After confirmation, they will be printed a pass for 90 days". As said Security Director (quote) "I want to know who is in here. I want safety". Now to speed the traffic, nobody requires ID, and it is common to see guards operate the barriers manually without verifying the valid permission to entry, which makes the community less safe than it was before.

Briefing Room: Preventing bicycle thefts

Hi Seal Beach,

Is anyone else enjoying the warmer weather as much as we are?

As the warm spring sun brightens and warms Seal Beach, we see more residents pumping up their bike tires and hitting the streets. While cycling offers numerous health benefits and is an eco-friendly transportation option, the increase in bicycle activity also comes with a rise in theft incidents. The Seal Beach Police Department is urging all cyclists to take preventive measures to protect their beloved bikes.

Bicycle theft is a prevalent issue that tends to spike as more people ride bikes in warmer

weather. We want to ensure that everyone takes the necessary steps to secure their bikes and prevent theft.

To combat this issue, we recommend the following bike protection tips:

- 1. Use a high-quality lock: Invest in a sturdy U-lock or a heavy-duty chain lock. Avoid using cable locks as they can be easily cut by thieves.
- 2. Lock it properly: Always (and we mean ALWAYS, even if you are gone for only a minute or two) secure your bike to a fixed object that cannot be easily broken or dismantled. Make sure to loop the lock through the frame and the wheels.
- 3. Be mindful of where you park: Choose well-lit and busy areas to park your bike. Avoid leaving it in secluded or poorly

lit areas for long periods.

4. Keep a record: Note down your bike's make, model, serial number, and any distinguishing features. This information can be crucial in recovering your bike if it gets stolen.

In addition to these tips, the SBPD strongly encourages residents to register their bicycles with Project 529. This bike registry system helps reduce bike theft and increase recovery rates through its unique registration and reporting platform.

Project 529 works by providing a secure and accessible registry where cyclists can register their bikes. Once registered, each bike is linked to its owner through a unique identifier, which can significantly aid in

A very important question, which must be answered - How much does the Project cost shareholders? According to LW weekly, February 23, 2023 (quote) "The system will cost about \$1,600 a month in operating expense".

The real expense is much higher. Only in 2023 GRF operating Budget, when the Project schedule to start in late summer, to Security Department were added seven Full-time positions (from 30 in 2022 to 37 in 2023). According to GRF Operating Statement, In 2023 ODO Agency was paid \$1,214,496, of which \$809,496 is

over the Budget. To hide the real cost of the Project Administration removed the Security Department from 2024 Budget. Now the Security Department is under Human Resources, which Budget increased in 2024 from \$573,416 in 2023 up to \$14,853,436, or 25.9

Where is located the cost of repairing the reported 25 broken barriers?

The Project must be immediately terminated, professional auditors to be hired to investigate all aspects of how it was mismanaged.

"In District 4, we are beginning repaving work this week on several streets in College Park East as part of our city's annual Pavement Management Plan. Also included will be the repaving of Almond Avenue, in the area of the sound wall reconstruction and other work in conjunction with the I-405 Improvement Project (this work will be paid for as part of the I-405 project). All street work is scheduled to be finished by Memorial Day.

"The Lampson Bike Lane Project is also underway and will continue until August. There will be intermittent lane closures as this project continues. The project will construct a uniform bike lane on both sides of Lampson, but must do some demolition in a few places to widen the traffic lanes. One of these areas is near the parking lot of the Seal Beach Tennis and Pickleball Center (SBTPC), where the sidewalk is being pushed back a bit. Another is the narrowing of a median closer to Seal Beach Blvd. In both places, trees had to be removed. I have heard from residents who were saddened by the removal of trees, especially the ones near the SBTPC which were 50 years old. It is indeed unfortunate that the trees had to go. However, when all of the work is finished, the ride for cyclists as well as drivers should be safer for everyone.

"The City of Los Alamitos released the Draft Environmental Impact Report (DEIR) for their proposed Lampson Park Place project at 4665 Lampson Avenue, last week. This project is directly across Lampson from the College Park East neighborhood, so there is a lot of interest about the project from CPE residents. I was told that Los Alamitos sent an information letter to every household in CPE, which told our residents where to find the DEIR document for study and how to make comments regarding the project. The deadline for public comments is 5:00 pm on June 10, 2024, to toliver@cityoflosalamitos.org."

Ongoing Upcoming

City looking at budget, possible sales tax

Seal Beach officials are looking at the budget, parking, a possible sales tax, and an update to the Seal Beach Zoning Code. That's not the complete list.

'Quite frankly I don't know of a time um since I've been here when our staff team has been tasked with so many overwhelming items in our workload," said City Manager Ingram during her report to the April 22 City Council meeting. (City officials expressed concern about the workload and staffing during the 2023 Strategic Planning meeting. See "City talks about staffing issues," at sunnews.org.)

According to Ingram, city staff is currently working on:

- The draft of the 2024-25 budget.
- The state-mandated update of Housing Element of the General Plan. (The state government has required Seal Beach to plan for 1,243 residential units.)
- The Zoning Code update. (In order to plan for more units, Seal Beach needs to change zoning citywide.)
- The EIR for the Zoning Code update.
- The Local Coastal Program. "The Coastal Act requires that governments develop Local Coastal Programs (LCPs) (consisting of Land Use Plans and Implementing ordinances) to carry out policies of the California Coastal Act at the local level," according to the California Coastal Commission website. "Once certified by the Coastal Commission as consistent with and adequate to carry out the Coastal Act, responsibility for issuance of most Coastal Development Permits under the certified LCP is delegated to the local government. The Commission retains some continuing permit and appeal jurisdiction following LCP certification, and responsibility to certify any amendments to the LCP.")
- Community polling to look at a possible sales tax. (The council discussed a possible sales tax during the 2024 Strategic Planning meeting held earlier this year. The city would have until August to put a sales tax measure on the ballot. See "SB Finance Director: 'City is not broke'" at sunnews.org.)
- The Old Ranch Country Club proposal. (The Old Ranch Country Club has applied for a new specific plan to allow development of the site for residential and hotel use. College Park East residents have expressed concerns about the project's potential impact on flooding.)






